Formula H2O & Wreck Racing League Rules and Regulations:

The rules, regulations, procedures, and information set forth herein are designed to provide for the orderly conduct of all Formula H2O and Wreck Racing League events and to establish minimum acceptable safety requirements for such events. These rules shall govern the condition of all Formula H2O and Wreck Racing League events, and, by participating in these events: all participants and all others are deemed to have complied with these rules. No expressed or implied warranty of safety shall result from the publications of, or the compliance with, these rules, regulations, or procedures. They are intended as a guide for the conduct of the sport and are in no way a guarantee against injury and/or death to participants, spectators, or all others.

Formula H2O and Wreck Racing League Officials shall be empowered to permit minor deviation from any specifications herein or impose any further restrictions. Any interpretation or deviation of these rules is left to the discretion of the Wreck Racing League Officials; their decisions are final.

FORMULA H2O AND THE WRECK RACING LEAGUE OFFICIALS RESERVE THE RIGHT TO REVOKE RACING PRIVILEGES AND CHANGE THESE RULES AT ANYTIME AT ANY TIME AND FOR ANY REASON.

Participants shall conduct themselves in a sportsman-like manner at all times before, during, and after an event, both on and off the course. Examples of unsportsmanlike conduct include, but are not limited to, deliberately hitting or kicking another participant, deliberately causing another participant to crash, reckless operation of equipment, showing blatant disregard for Formula H2O/Wreck Racing League rules or officials, and being under the influence of drugs or alcohol while competing in an event.

There will be no tolerance for alcohol or drugs consumed by any competitor, crew, or anyone else during any marine operations and/or loading and unloading of boats. Removal from event may be without warning and without a refund.

General Safety Rules:

1. All participants must read and sign the attached release waiver (Page 2 & 3) and other release forms as required by charter operators.
2. All SCUBA participants are responsible for monitoring their own air supply and must return to the boat with at least 500 PSI at the conclusion of each dive.
3. All SCUBA participants must use a buoyancy compensator with a power inflator connected to at least 80 cubic feet of breathable air or nitrox mixture with quick release weights.
4. It is the sole responsibility of the participant's using SCUBA with Nitrox or non-ambient air mixtures to inspect and determine if the mixture is safe for the diving event.
5. It is the sole responsibility of the participant to inspect and configure all equipment used by the participant.
7. All equipment used by participants is subject to the approval of Formula H2O and Wreck Racing League officials.
8. All freediving or snorkel participants or participants not using SCUBA must operate within safe limits and are responsible for their own safety.
9. All participants must take part in pre-dive briefings and must follow all instructions from the Boat Captain, Dive Master, Safety Officers and other staff and volunteers assigned to assist in the care and safety of all participants.
10. All participants may not make any intentional contact with other participants at any time during the submerged practice or race events.
11. Participants may not intentional block other participants on the course which could result in contact.

WRECK RACING LEAGUE LIABILITY AND ASSUMPTION OF RISK AGREEMENT & PHOTO RELEASE

Please read carefully and fill in all blanks before signing.

I, _____, hereby declare that I am a certified diver,

Trained in safe diving practices, and affirm that I am aware that skin and scuba diving have inherent risks which may result in serious injury or death. I further acknowledge this document serves as a liability and assumption of risk agreement & photo release for all Formula H2O activities from midnight (ET) Friday July 29, 2011 to Midnight (ET) Sunday July 31, 2011.

I understand that diving with compressed air involves certain inherent risks; including but not limited to decompression sickness, embolism or other hyperbaric/air expansion injury that require treatment in a recompression chamber. I further understand that the open water diving trips which are necessary for this experience may be conducted at a site that is remote, either by time or distance or both, from such a recompression chamber. I still choose to proceed with such experience dive(s) and racing activities in spite of the possible absence of a recompression chamber in proximity to the dive site.

I understand and agree that neither the dive professionals, the facility through which this experience is offered, Wreck Racing League, Vandenberg Entertainment LLC, it's volunteers, advisory board members, board members, event sponsors, event vendors nor its affiliate and subsidiary corporations, nor any of their respective employees, officers, agents, contractors or assigns (hereinafter referred to as "Released Parties") may be held liable or responsible in any way for any injury, death or other damages to me, my family, estate, heirs or assigns that may occur as a result of my participation in this experience or as a result of the negligence of any party, including the Released Parties, whether passive or active.

In consideration of being allowed to participate in the dive(s), I hereby personally assume all risks of this experience, whether foreseen or unforeseen, that may befall me while I am a participant in this experience. I further release, exempt and hold harmless said experience and Released Parties from any claim or lawsuit by me, my family, estate, heirs or assigns, arising out of my enrollment and participation in this experience, including both claims arising during the experience or after I complete the experience.

I also understand that skin diving, snorkeling, free diving and scuba diving are physically strenuous activities and that I will be exerting myself during this experience, and that if I am injured as a result of heart attack, panic, hyperventilation, drowning or any other cause, that I expressly assume the risk of said injuries and that I will not hold the Released Parties responsible for the same.

I understand that past or present medical conditions may be contraindicative to my participation in this experience. I declare that I am in good mental and physical fitness for diving, and that I am not under the influence of alcohol, nor am I under the influence of any drugs that are contra indicatory to diving.

If I am taking medication, I declare that I have seen a physician and have approval to dive while under the influence of the medication/drugs.

I will inspect all of my equipment prior to this experience and will notify the Released Parties if any of my equipment is not working properly. I will not hold the Released Parties responsible for my failure to inspect my equipment prior to diving.

I further state that I am of lawful age and legally competent to sign this liability release, or that I have acquired the written consent of my parent or guardian. I understand the terms herein are contractual and not a mere recital and that I have signed this Agreement of my own free act and with the knowledge that I hereby agree to waive my legal rights. I further agree that if any provision of this Agreement is found to be unenforceable or invalid, that provision shall be severed from this Agreement. The remainder of this Agreement will then be construed as though the unenforceable provision had never been contained herein.

COMPLETE BOAT LIABILITY RELEASE AND WAIVER

I UNDERSTAND THE PURPOSE OF SIGNING THIS DOCUMENT IS TO EXEMPT AND RELEASE SOUTH FLORIDA DIVING HEADQUARTERS, INC., JEFF TORODE, THE VESSELS AQUA VIEW, CORAL PRINCESS AND SAFARI DIVER, THEIR OWNERS, EMPLOYEES, CREW, DESIGNEES, AGENTS, SPONSORS, VOLUNTEERS AND ADVERTISERS, AS WELL AS ALL INVOLVED DIVE BOATS, WHETHER OWNED, OPERATED, LEASED OR CHARTERED AND TO HOLD THESE ENTITIES AND INDIVIDUALS (THE "RELEASED PARTIES") HARMLESS FROM ANY AND ALL LIABILITIES ARISING AS A RESULT OF ANY ACTS OR OMISSIONS ON THEIR PART, INCLUDING, BUT NOT LIMITED TO, ACTIVE OR PASSIVE NEGLIGENCE OR NEGLIGENCE OF ANY TYPE.

I understand that scuba diving is a hazardous activity with inherent risks and dangers associated therewith including, but not limited to, risks associated with equipment failure, perils of the sea, as well as acts of fellow divers which could result in my serious injury or death. BY WAY OF MY SIGNATURE I EXPRESSLY ASSUME ALL RISKS OF SCUBA DIVING OR SNORKELING OR SWIMMING, and ALL ASSOCIATED RISKS, WHETHER THESE RISKS ARE SPECIFICALLY SET FORTH OR NOT. IT IS MY INTENTION TO RELEASE THE RELEASED PARTIES FOR ANYTHING THAT MIGHT HAPPEN DURING TO ME WHICH RESULTS IN PERSONAL INJURY OR DEATH.

By my signature on this release, I assert that I am physically fit to participate in the activity of swimming, scuba diving and snorkeling and I agree by way of my signature that I will not hold any of the released parties or above named individuals, persons, or entities responsible if I am injured as a result of any medical conditions while swimming, Scuba diving and/or snorkeling. I do not have in my possession any illegal drugs, nor am I taking, nor have I recently taken any drugs or medications which could cause an adverse reaction as a result of combining such drugs and/or medication with scuba diving.

Prior to diving, I will inspect all equipment to be used to make sure that it is in good operating condition. I will not hold the released parties or anyone else responsible for my failure to inspect my equipment prior to diving or for any equipment failure which may occur.

I understand that I have an affirmative duty to plan and carry out my own dive and to be responsible for my own safety. By way of my signature I expressly agree that I will plan all my dives as no decompression dives and within safe limits of recreational scuba diving.

I am fully aware and have been trained in the dangers, risks and hazards of holding my breath while diving on compressed air. I fully agree not to hold the released parties responsible for any such injuries sustained by me.

I understand that this diving activity may be conducted in a remote site by time and distance from a medical facility and a recompression chamber. Nevertheless, I expressly wish to proceed with this diving activity and assume all related risks. I understand there is no obligation on the part of the released parties to provide medical assistance or first aid.

BY WAY OF MY SIGNATURE ON THIS DOCUMENT IT IS MY EXPRESS INTENTION TO GIVE UP MY RIGHT TO SUE ALL INDIVIDUALS, OR ENTITIES OR VESSELS REFERRED TO HEREIN, (THE "RELEASED PARTIES") WHETHER SPECIFICALLY NAMED OR NOT, FROM ALL LIABILITY ARISING AS A CONSEQUENCE OF ANY ACT OR OMISSION INCLUDING, BUT NOT LIMITED TO, ACTIVE OR PASSIVE NEGLIGENCE, INCLUDING GROSS NEGLIGENCE. I FULLY AGREE TO INDEMNIFY AND HOLD THE RELEASED PARTIES HARMLESS FROM ANY AND ALL LIABILITY FOR PERSONAL INJURY OF ANY SORT, INCLUDING WRONGFUL DEATH ON BEHALF OF MYSELF, MY HEIRS AND ASSIGNS, AND I EXPRESSLY ASSUME ALL RISKS IN CONNECTION WITH SWIMMING, SNORKELING AND SCUBA DIVING ACTIVITIES.
